Competitor Requirements	<p>Each competitor must possess an FAI Sporting Licence valid for 2024 and especially for the period of the event. The competitors shall be listed in the FAI Sporting Licence database. The unique FAI ID number shall be provided during the registration period.</p> <p>Necessary information can be retrieved at the following link <a href="https://fai.org/page/sporting-licence">https://fai.org/page/sporting-licence</a> The holder of an FAI Sporting Licence may be required to present an official document bearing his photograph and signature as proof of identity.</p>
Competitor Numbers	The number of competitors is limited to 30 pilots. Pilots registration will be made in chronological order.
Entry Period	Entry will close two weeks before the competition.

Entry Fee	The entry fee is 85,00 EUR. Entry is not confirmed until payment has been received.
Protests	<p>C.20.2 Protest</p> <p>a) All protests must be presented in writing in English to the contest director of the event, or the appropriate contest director for an event with multiple classes and must be accompanied by the deposit of a fee. The amount of this fee shall be the equivalent of 50 Euro. The deposit is returned only if the protest is upheld.</p> <p>b) The same person (team manager or competitor depending on the type of contest) is not permitted to present two consecutive protests on the same incident.</p> <p>c) Protests must be arbitrated in compliance with FAI Sporting Code General Section 6.4.</p>
Rules	<p>The competition will be run in accordance with the FAI Sporting Code Section 4 – Aeromodelling, Volume F3, Radio Control Aerobatics.</p> <p>The following frequency bands are the only ones allowed for this competition to comply with Dutch legislation. Spot checks may be made to check for compliance.</p> <p>1) Model aircraft use only 34.945 MHz to 35.305 MHz. Effective radiated power 100 mW.</p> <p>2) General use 2.4Ghz Effective radiated power 100 mW.</p>
No. of rounds/schedules	Three rounds of P25 Schedule for all pilots with the best two flights plus one round of F25 for the top 10 pilots counting.
